As you may be aware, The American Rescue Plan (ARP) was signed on March 11, 2021. The ARP allocated additional funding for the Higher Education Emergency Relief Fund (HEERF), which provided CARES Act and CRRSAA payments to students over the past year. Washington & Jefferson College's allocation was \$1,712,147, which must be made available directly to students as emergency grants for any

component of a student's cost of attendance or emergency cost that arise due to Coronavirus such as tuition, food, housing, health care, mental health care, or child care.

According to current federal policy, the American Rescue Plan allows for expanded uses of HEERF funds, and according to current federal policy, any student who is or was enrolled at W&J on or after March 13, 2020, the date of the declaration of the national emergency due to the Coronavirus, is eligible. Therefore, international students, students who have stopped out, or students who have withdrawn are eligible for emergency grants under the ARP. In addition, unlike CARES funds, ARP funds do not relate to the disruption of campus operations due to Coronavirus. Also, students do not need to meet Title IV eligibility and may grant the College permission to credit their emergency grant to their student account.

You are receiving this message because you have been identified as eligible to receive an emergency grant under the ARP. All eligible students will receive an initial grant of \$600. You do not need to take any action to receive your emergency grant. However, to provide the College with written permission to credit your grant to your student account balance (past due or Fall 2021), please complete this <u>form</u> no later than 5 PM EST on Tuesday, July 20, 2021. If you do not opt to credit your grant to your student account, a check will be mailed to your home address beginning July 23, 2021.

For those students who self-identify as having exceptional need, an appeals process will be made available in October; more information will be provided during the Fall 2021 semester. Be sure to monitor campus announcements, your My W&J and student e-mail accounts, and the College's emergency grant FAQ page for more information.
